Persons of wisdom and maturity of faith, with demonstrated leadership skills and being compassionate in spirit, they exercise government, leadership, spiritual discernment, and discipline and have responsibilities for the life of a congregation as well as the whole church, including ecumenical relationships. Ruling elders are elected to a 3-year term and must be members of GPC. Together, the elders form the Session, which comprises 3 classes, with 7 members in each class.
